Directions to the show site (see maps and aerial picture):

From Detroit: I-96 west to US-127; north to Kalamazoo St. exit.

From Grand Rapids: I-96 east to I-69; east to US-127; south to Kalamazoo St exit.

From Flint: I-69 west to US-127; south to Kalamazoo St exit.

From Battle Creek: I-94 east to I-69; north to I-96; east to US-127; north to Kalamazoo St exit.

From Jackson: North on US-127 to Kalamazoo St exit.

Kalamazoo St east (past Harrison Rd). Demonstration Hall is the dark brown brick building on the right, turn right on the second street just before it (Demonstration Hall Rd). Parking is along side of the short street, or in the lots across the streets to the west or east of the building. **DO NOT PARK IN AREAS INDICATED AS NO PARKING - FIRE LANES, AS VEHICLES IN THESE AREAS WILL BE TOWED!**
