Please note:

- 1) Catalogs - \$4.00 each available at the Trial Secretary's table. One catalog covers all 3 days. There will be a list of those who pre-paid. Only a limited number of extra copies will be available for sale.
- 2) Food - concessions will be available on site - please plan accordingly.
- 3) Crating area - as shown on the building layout on the back. Crates and chairs may be left overnight.
- 4) Don't forget to pick up after your dog at this site. There are several nice areas to exercise the dogs on grass, we'd like to keep it that way.
- 5) Timing - A general rule is to allow 6 dogs/hour in Utility, 7 dogs/hour in Open, 8 dogs/hour in Novice and 22 dogs/hour in Rally. This does not take into account absentees or individual judge's speed. Please give yourself enough time to be ready.
- 6) **Again this year - if your dog finishes a title at our trial, we offer a New Title rosette! Ask the table steward for a form. Big thanks to the Schultz Veterinary Clinic for sponsoring these!**
- 7) **Cell phone of trial secretary 517-474-3233 – if there is a problem.**
- 8) **Move ups are allowed from one level to another (Novice to Open, etc). You cannot move from A to B in the same level (Utility A to Utility B, for example).**
- 9) **The following class lists were accurate when printed. Please remember that move-ups can change the entry numbers in any regular class.**

Directions to the Show Site:

Directions from the southeast intersection of I-96 and M-127

Take I-96 west. Merge onto I-496 W via EXIT 106B toward DOWNTOWN LANSING.

Take the WAVERLY ROAD exit. Turn north on Waverly Road, (right) Follow Waverly Road all the way to Grand River Avenue (about 4 miles) and turn east (right) on Grand River. Go about a half mile, just past the entrance to Capitol City Airport, to the training building behind the Johnson's Speed Shop.

From the south (I-69) or west (I-96)

From I-96 /I-69, Take the I-96-BL / GD RIVER AVE exit- EXIT 90. Turn LEFT onto W GRAND RIVER AVE / W GRAND RIVER HWY / I-96 BL. Continue to follow W GRAND RIVER AVE / I-96 BL to 3940.5 Grand River Avenue on the north side of the road behind the Johnson's Speed Shop.

From the North or Northeast

Take I-69 west towards Grand Rapids. Exit at Airport Road. Take Airport Road south to where it ends at Grand River Avenue. Turn east (left) at Grand River. Go about a half mile, just past the entrance to Capitol City Airport, to the training Building behind the Johnson's Speed Shop.
